# COMMITMENT TO PRODUCT CONFORMITY WITH EUDR REGULATIONS

C.R.C.K.2 Company commits to fully comply with the European Union regulations to prevent the import of goods related to deforestation, ensuring that our rubber products are produced sustainably, do not harm the environment and comply with current legal requirements of Cambodia.

Our commitment contents include:

### 1. Product traceability

We ensure that all rubber products are fully traceable, from raw material exploitation to processing and sales. C.R.C.K.2 Company uses a modern traceability system that connects the entire supply chain, providing detailed information on the exploitation location, time and method. We commit that rubber products do not originate from the areas at risk of deforestation after December 31, 2020, strictly complying with the EUDR requirements.

#### 2. Non-deforestation commitment

C.R.C.K.2 Company commits that our rubber plantation gardens comply with the principle of "non-deforestation" by ensuring that all land areas used for rubber plantation have been legally licensed before December 31, 2020. To ensure the integrity of the forest and ecosystem surrounding the project area, the Company does not expand the plantation area.

# 3. Environmental management and protection

We apply environmental management measures according to ISO 14001, the Cambodian Environment and Natural Resources Code, ensuring that latex exploitation activities do not cause harm to water, land and air resources around the project area. C.R.C.K.2 Company always finds solutions to optimize rubber care and latex exploitation methods to minimize impacts on the ecosystem and protect biodiversity. We continuously improve the rubber care and latex exploitation process to achieve a balance between economic exploitation and environmental protection.

# 4. Consultation and protection of community rights

The Company always respects the interests of local communities and stakeholders around the project area. We conduct community consultations transparently, ensuring

local economic, cultural and social interests. All decisions related to land, environment and security cooperation are made through discussion and consensus with local population groups.

# 5. Transparent reporting and regular audits

C.R.C.K.2 Company commits to provide transparent information about our rubber production activities, including periodic reports on environmental impacts, land ownership and implementation of sustainable development measures, etc. on the Company's website and other mass media. We also conduct internal audits and invite independent audit organizations to conduct periodic assessments to ensure compliance with all EUDR regulations. All reports shall be widely publicized and sent to competent authorities for verification. With a high sense of responsibility, C.R.C.K.2 Company commits to comply with EUDR requirements, contributing to environmental protection, preventing deforestation and promoting sustainable development for the rubber industry.
