The Ministry of Environment has approved the completed Environmental and Social Impact Assessment (ESIA) report for the rubber plantation investment project on an area of **1,431,24 hectares** in Boeng Pe Conservation Area, Popok Commune, Stoung District, Kampong Thom Province and Pong Ror Ler Commune, Chi Kraeng District, Siem Reap, implemented by C.R.C.K.2 Aphivath Caoutchouc Co., Ltd. I am **Nguyen Duy Linh**, born on January 2, 1963, a businessman, and a Vietnamese citizen; Passport No.: P VNM N1822706, issued on May 12, 2017, expiring on May 12, 2027; and I am the General Director of C.R.C.K.2 Aphivath Caoutchouc Co., Ltd.

ENVIRONMENTAL PROTECTION COMMITMENT:

To contribute to the sustainability of the environment during the country's development I hereby enter into the environmental protection agreement with the Ministry of Environment for the rubber development project on an area of **1.431,24 hectares** in Popok Commune, Stoung District, Kampong Thom Province and Pongro Ler Commune, Chi Kraeng District, Siem Reap Province (Project II) of C.R.C.K.2 Aphivath Caoutchouc Co., Ltd under the following terms:

Article 1:

The company shall be responsible for and implement the contents as stated in the completed environmental and social impact assessment report for the rubber plantation investment project, which has been approved by the Ministry of Environment.

Article 2:

The company commits to paying into the environmental and social funds of the Ministry of Environment, specifically as follows:

a. Environmental Fund

- **USD 7,000 per year** from 2019 to 2021.
- **USD 14,000 per year** from 2022 until the project completion.

The above amount shall be used for: (1) environmental restoration and afforestation, (2) biodiversity and natural resource conservation, and (3) training of central and local human resources.

b. Social Fund

- **USD 5,000 per year** from 2019 to 2021.
- **USD 10,000 per year** from 2022 until the project completion.

The above amount shall be used for: (1) infrastructure development and local development, (2) public welfare programs, and (3) improvement and enhancement of the quality of education and charitable activities.

Article 3:

The Company shall provide a six-month environmental monitoring report to the Department of Environmental Impact Assessment, Ministry of Environment, for review and evaluation.

Article 4:

In the event that the Ministry of Environment requests the investor to adjust some environmental techniques to comply with the guidance and environmental standards, the company shall implement all the guided contents.

Article 5:

In the future, if the Company expands, changes the production line, or ceases operations, the Company shall notify the Ministry of Environment one month in advance.

Article 6:

The Company shall allow officials of the Ministry of Environment or the Provincial Department of Environment of Kampong Thom or Siem Reap with a valid work permit to inspect the project.

Article 7:

The company shall donate **USD 1,000 per year** to the environment fund in December 2019. This amount shall be paid to the Ministry of Environment annually until the completion of the investment project.

Article 8:

In the event that the Company fails to comply with any of the provisions or acts in violation of this commitment or any relevant regulations, the company shall be held legally responsible.
