My name is **Nguyen Duy Linh**, date of birth: January 2, 1963, occupation: businessman, nationality: Vietnamese; passport No.: P VNM N1822706, date of issue: May 12, 2017, expiry date: May 12, 2027; I am the General Director of C.R.C.K.2 Aphivath Caoutchouc Co., Ltd.

### **HEREBY MAKE A COMMITMENT TO ENVIRONMENTAL PROTECTION:**

To contribute to ensuring environmental sustainability in the process of national development, I hereby make a commitment to environmental protection with the Ministry of Environment regarding the Rubber Latex Processing Factory project on an area of **34.70** hectares in Popok Commune, Stoung District, Kompong Thom Province of C.R.C.K.2 Aphivath Caoutchouc Co., Ltd under the following terms:

#### **Article 1:**

I shall take responsibility and comply with the contents stated in the initial environmental and social impact assessment report (IESIA), which was fully approved by the Ministry of Environment regarding the Rubber Latex Processing Factory project.

#### **Article 2:**

I commit to contributing to the environmental and social funds to the Ministry of Environment starting from December 2019 with the amount of **8,500 USD/year**, specifically as follows:

**a. Environmental Fund:** Pay **5,000 USD/year** for environmental restoration and tree planting.

**b. Social Fund:** Pay **3,500 USD/year** for organization of training and retraining programs on skills and knowledge of environmental staff.

#### **Article 3:**

I will be responsible for collecting, cleaning, and treating all types of waste in the investment area according to Articles 15, 16, 17, 18, and 25 of the Government Decree No. 113 dated August 27, 2015 on the management of waste and garbage.

#### **Article 4:**

Our Company will provide an environmental monitoring report every 6 months to the Department of Environmental Impact Assessment, Ministry of Environment for review and assessment.

#### **Article 5:**

In case the Ministry of Environment requires the investor to modify some environmental techniques in accordance with the guidance and environmental standards, our Company will fully comply with the guidelines provided.

#### **Article 6:**

In the future, if our Company expands or changes the production line or stops operation, we will notify the Ministry of Environment at least 01 month in advance.

#### **Article 7:**

I authorize officials of the Ministry of Environment or the Kampong Thom Provincial Department of Environment, who hold valid assignments, to inspect the project as per regulations.

**Article 8:**

Our Company will make an environmental contribution of **1,000 USD/year** in December 2019. This amount will be paid annually to the Ministry of Environment until the investment project is completed.

**Article 8:**

In case our Company fails to comply with any provision or violates this commitment or other relevant regulations, our Company shall be responsible before the law.
