My name is **Nguyen Duy Linh**, date of birth: January 2, 1963, occupation: businessman, nationality: Vietnamese; passport No.: P VNM N1822706, date of issue: May 12, 2017, expiry date: May 12, 2027; I am the General Director of C.R.C.K.2 Aphivath Caoutchouc Co., Ltd.

HEREBY MAKE A COMMITMENT TO ENVIRONMENTAL PROTECTION:

To contribute to ensuring environmental sustainability in the process of national development, I hereby make a commitment to environmental protection with the Ministry of Environment regarding the rubber plantation investment project on an area of 1,431.24 hectares in Popok Commune, Stoung District and Pongro Ler Commune, Chi Kraeng District, Siem Reap Province (Project II) of C.R.C.K.2 Aphivath Caoutchouc Co., Ltd under the following terms:

Article 1:

I shall take responsibility and comply with the contents stated in the completed environmental and social impact assessment report, which was fully approved by the Ministry of Environment regarding the rubber plantation investment project.

Article 2:

I commit to contributing to the environmental and social funds to the Ministry of Environment, specifically as follows:

a. Environmental Fund

- Pay **7,000 USD/year** from 2019 to 2021.
- Pay 14,000 USD/year from 2022 until the end of the project.

The above amount will be used for: (1) environmental restoration and tree planting, (2) biodiversity and natural resource conservation, (3) training of human resources at central and local levels.

b. Social Fund

- Pay **5,000 USD/year** from 2019 to 2021.
- Pay 10,000 USD/year from 2022 until the end of the project.

The above amount will be used for: (1) infrastructure construction and local development, (2) public welfare programs, (3) improvement and enhancement of the quality of education and charitable activities.

Article 3:

Our Company will provide an environmental monitoring report every 6 months to the Department of Environmental Impact Assessment, Ministry of Environment for review and assessment.

Article 4:

In case the Ministry of Environment requires the investor to modify some environmental techniques in accordance with the guidance and environmental standards, our Company will fully comply with the guidelines provided.

Article 5:

In the future, if our Company expands or changes the production line or stops operation, we will notify the Ministry of Environment at least 01 month in advance.

Article 6:

I authorize officials of the Ministry of Environment or the Kampong Thom Provincial Department of Environment, who hold valid assignments, to inspect the project as per regulations.

Article 7:

Our Company will make an environmental contribution of **1,000 USD/year** in December 2019. This amount will be paid annually to the Ministry of Environment until the investment project is completed.

Article 8:

In case our Company fails to comply with any provision or violates this commitment or other relevant regulations, our Company shall be responsible before the law.
